## Directive no. 21/2022 of the Rector of WSB University in Poznań of 29 April 2022

## on the distribution of financial resources allocated to financial support for students in the 2021/2022 summer semester

Acting pursuant to § 20(1)(2)(b) of the Bylaws of WSB University in Poznań granted under Resolution no. 15/25/2021 of 15 June 2021 of the Management Board of Centrum Rozwoju Szkół Wyższych TEB Akademia sp. z o.o., the Founder of the University, on introducing changes in the "Bylaws of WSB University in Poznań" in connection with § 2(1)(6) of the Regulations on granting and disbursing benefits to students of WSB University in Poznań implemented by ordinance no. 29/2019 of the Rector of WSB University in Poznań of 23 September 2019, I hereby decide as follows:

\$1

- 1. I determine the distribution of funds from the state budget allocated to financial support for students in the 2021/2022 summer semester.
- 2. The distribution has been made in agreement with the council of the self-governing students' union of WSB University in Poznań and in accordance with Article 91(3) of the Act on Higher Education and Science of 20.07.2018 (Journal of Laws 2018, item 1668 as amended), i.e. the grant funds allocated to the rector's scholarships for the best students awarded to no more than 10% of the number of students in each field of study at the university constitute no more than 60% of the total funds allocated to the rector's scholarships for the best students, social scholarships and financial aid. If the number of students in a field of study is less than ten, the rector's scholarship for the best students may be awarded to one student.

§ 2

Pursuant to Article 92(3) of the Act on Higher Education and Science, the total monthly amount of the scholarships referred to in Article 86(1)(1) and (4) (social scholarship and the rector's scholarship) for a student may not exceed 38% of a professor's remuneration established on the basis of the Regulation of the Minister of Science and Higher Education of 25 September 2018 on the minimum monthly basic remuneration for a professor in a public university (Journal of Laws 2018, item 1838), i.e. PLN 2,435.80.

§ 3

The maximum amount of financial aid may not exceed PLN 3,000.

This directive comes into force on the day of its issuance and remains valid until the end of the 2021/2022 summer semester.
